

Terms and Conditions

U.S. passport valid through end of November 2026 is required; non-U.S. passport, please contact tour operator.

Payment schedule: \$500 deposit required no later than October 15; **however, tour registration is first-come, first-served**, so after all places are filled, no further registrations will be accepted; register early to avoid disappointment. Second payment of \$2500 will be due November 15, 2025, and final payment of \$2495, will be due January 15, 2026 (plus any optional cabin upgrade with final payment). Deposits and payments are not transferable. Credit cards may be used for second and final payments with a non-refundable 3% processing fee, which will show up on credit card statements from Expedition and Travel, Athens, Greece.

Tour price includes . . .

Round-trip air on scheduled airline from Cincinnati. Cancellations after air tickets are issued are subject to a cancellation penalty as imposed by the airline. Current air fuel charge and taxes/fees are included. Please note: frequent flyer miles or credit card points cannot be used to purchase or upgrade air tickets; however, if you arrange your own airfare for whatever reason (fly earlier than group, different airline, using miles or points, upgrading to premium seats), deduct \$1400 per person at time of final payment.

Accommodation in 4-star hotels, exterior stateroom with window on cruise, both with private bath. Anyone staying in a single room on land tour and exterior cruise cabin additional \$1695. Cost to upgrade cruise to standard balcony cabin \$265 per person; upgrade to premium Junior Suite balcony stateroom \$485 per person. Upgrade for single cabin/stateroom is double the above. Interior cabin with no window may be available at reduced price, please inquire.

Meals daily buffet breakfasts and dinners and one lunch on land tour, all meals on cruise.

Sightseeing in the itinerary including entrance fees and services of English-speaking guides and tour escorts. Four shore excursions are included: walking tours of Mykonos and Santorini, full guided tours of Ephesus and Patmos.

One regular-sized suitcase, maximum 50 pounds, is currently allowed free of charge plus one personal item and one "carry-on" that will fit under in the overhead bin. Tour organizers accept no liability for loss or damage to any baggage.

All tips for land tour and cruise ship personnel are included. Shore excursion tips are optional and not included.

Tour price does not include sightseeing or services not specifically mentioned or noted as optional; baggage charges that may be implemented by airlines (none as of this printing); government "sustainability" fees for island visits (total currently \$35).

Cancellation policy: No penalty for written cancellations received before October 15, 2025. Written cancellations received October 15-November 14 are subject to a \$500 per person cancellation fee. Written cancellations received November 15-December 14 are subject to 25% cancellation fee of the total tour price. Written cancellations received December 15, 2025-February 28, 2026, are subject to a 50% cancellation fee of the total tour price. No refund for written cancellations received after February 28. No refund made for missed services while on tour. In addition to the above cancellation fees, airline tickets are not refundable once issued. We recommend the purchase of travel insurance, which covers medical expenses as well as reimbursement for cancellation penalties and other covered eventualities such as trip interruption.
